

**Official Rules.**  
**No Purchase Necessary to Enter or Win.**  
**PIN-Based and International Transactions Not Eligible For Automatic Entry.**

All entries, whether submitted by using a consumer Community Bank of Fitzgerald Debit MasterCard® card (hereinafter, "Card") as described below or by mail, have an equal chance of winning.
